

DECLARATION OF INTERESTS (experts)

Because of the nature of decisions made by the Pharmaceuticals Pricing Board, it is important that also experts giving statements to the Pricing Board provide their Declaration of Interests - even if they are not otherwise involved in dealing with the matter in question.

This form gives information on interests, commitments and other issues that might interest the readers of an expert statement. Information should be given even about matters which the readers of an expert statement might think have affected the content of the statement or which may seem to have affected the content. In the case some matters might be unclear, it is better to give plenty of information than no information at all. **If the spouse or children of the person giving the statement have any connections mentioned below, even those connections should be declared. Interests and commitments from the last three years must be declared.**

INSTRUCTIONS

Below you can find examples of interests and commitments. Please note that the list is not comprehensive. In the square brackets you can find samples of how to express the required information.

1. You were invited as a lecturer to events organised by healthcare or pharmaceutical companies, and you received compensation for the lectures. There is no need to declare a lecture given only once. [Several lectures given at training events organised by healthcare and/or pharmaceutical companies (companies A, B and C).]
2. You received compensation for your input in the planning of a training event organised by healthcare and/or pharmaceutical companies. [Participated in the planning of training events organised by healthcare or pharmaceutical companies (companies A and B).]
3. You travelled abroad to a congress and your expenses were paid by a healthcare and/or pharmaceutical company; travel expenses and/or participation fee included. [Travelled to a congress abroad, financial support provided by a healthcare and/or pharmaceutical company or several companies (companies A, B, C and D).]
4. You or your research group were granted research funding from a healthcare and/or pharmaceutical company fund or something similar. [Received a grant from a healthcare and/or pharmaceutical company fund (companies A and B).]
5. You gave expert help to a healthcare and/or pharmaceutical company and received compensation for your efforts. [Acted as an expert for a company (companies A and B).]
6. You worked as head researcher or researcher for a company, e.g. carrying out research on marketing authorisation. [(Head) Researcher for a company (companies A and B).]
7. You hold either the full patent right or a partial patent right to the preparation in question, or to a competing preparation. [Patent (preparations A and B).]
8. You participate in the operations of a healthcare and/or pharmaceutical company, or its administrative body. [Participate in the operations of a healthcare and/or pharmaceutical company (company A).]
9. You hold shares, or something similar, the income from which is significant in relation to your income from your main job, or the shares give you the possibility to affect the operations of the company or society. [Own a significant number of shares in a healthcare and/or pharmaceutical company or companies (company A).]
10. You act as an expert for a patient association or something similar. [Act as an expert for an association (associations A and B).]
11. Some other reason that would compromise your impartiality.

There is no need to declare assignments of the following kind:

1. You participated in a free training event funded by a healthcare and/or pharmaceutical company or something similar, and received a meal there. [No interests or commitments.]
2. You were invited as a lecturer to an event organised by a health centre, a hospital clinic or an association that is receiving financial support from a healthcare and/or pharmaceutical company. [No interests or commitments.]
3. You were granted research funding via application from a fund whose capital is partly financed by the healthcare and/or pharmaceutical industry. [No interests or commitments.]
